GENERAL INFORMATION

- **ENTRY LIMIT:** Match is limited to 20 dogs. Eight (8) at novice level. Seven (7) at open level. Five (5) at excellent level. If the match fills a waiting list will be kept. Handlers may only handle 1 dog in the 3 components at each level.
- **ELIGIBILITY:** Purebred or mixed-breed dogs must be at least 6 months of age that:
 - a) Are individually registered with the CKC (have a CKC registration number)
 - b) Have an Event Registration Number (ERN)
 - c) Have a Performance Event Number (PEN)
 - d) Are eligible for registration with the CKC, or
 - e) Have a Miscellaneous Certificate Number (MCN) if it belongs to a CKC listed breed
 - f) Have a Canine Companion Number (CCN) if it is a mixed-breedDogs that are eligible for a CKC or ERN but don't yet have one should have a Temporary Competition Number (TCN). These can be obtained free of charge online from the CKC. For this event, dogs may still run as "listed". For more information about the TCN:

- **RUNNING ORDER:** will be emailed to handlers one day before the match. A running order will be posted on site for reference. Check in at 9-9:30 am. First dog on the start line at 10:00 am.

- ODOURS: Novice - Wintergreen
Open – Wintergreen and/or Pine
Excellent- Wintergreen and/or Pine and/or Anise
- EQUIPMENT: The dog may wear a buckle, snap or martingale collar and/or body harness in the ring. Collars/harnesses with tags may be worn in the ring. Harnesses may have the leash attached to the front clip or on the back. Electronic training and pinch collars are not allowed on the grounds.
- REFUNDS: Entry fees will not be refunded after February 10, 2023 @ 7:00 pm. In the event that a dog is absent, disqualified, excused by a judge or barred from competition by action of the Match Committee or the Canadian Kennel Club, or if it is impossible to open or complete the test, no refund of entry will be made.
- BITCHES IN SEASON: Bitches in season are not permitted to compete. If a bitch comes into season after entries have closed, the club will refund the entry fee providing the event secretary receives, on or before the event, a veterinarian's certificate declaring that the bitch was in season within the 10-day period preceding the match.
- TEST SITE: No indoor kenneling. **This match will run rain or shine**. All dogs must be under control, on a leash except during the match where off leash searches are permitted. **Flexi leads will not be allowed on the test site**. Remember that this is a public park used by families. Clean up after yourself and your dog. Bathroom facilities are on site. A concession is available at Planet Ice within walking distance of the venue.
- REGULATIONS: It is the responsibility of the exhibitor to be familiar with the rules pertaining to the event in which they are competing. - CKC REGULATION: It shall be the duty and obligation of the match-giving club to see that a judge, club official, volunteer or any participant at an event held under these rules is not subject to indignities of any kind. The Match Committee Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report indicating that this has occurred.
